2018 MEMBERSHIP CATEGORIES

Family (\$550) – shall include legal parents/guardians and all dependents whose principal place of residence is the same as the parent/ guardian. A Family membership consists of a maximum of 2 adults who share a primary residence or are/were related by marriage. *Equity membership.*

One + One (\$380) – Member and one additional individual whose principal place of residence is the same. *Equity membership.*

- Spouses/Partners – two adults who share the same place of residence.
- Empty Nest – Former family membership whose adult children are no longer on the membership.
- Parent/Child – one parent or legal guardian and one dependent who has not reached his/her 22nd birthday by opening day, and whose principal place of residence is the same as the parent or legal guardian.

Individual (\$300) – shall include all persons who have reached the age of 18 by opening day who do not qualify for another type of membership. *Equity membership.*

Military (\$340 individual; \$575 family) – available to individual/families in which one or both parents are on active military duty. It includes the use of Robin Hood's facilities for one year, with *no voting rights or equity in the Corporation.*

Temporary (\$450 individual; \$700 family) – a **limited** number of new memberships are available. The number of temporary memberships will be set annually by the RH Board based on total equity memberships. It includes the use of Robin Hood's facilities with *no voting rights or equity.*

August Only (\$199) – access and full privileges from August 1, 2018 through the closing of the Pool in September. Limited memberships available; number of available memberships will be determined annually by the RH Board. *No voting rights or equity.*

MEMBERSHIP ADD-ONS

Adult Dependent (\$125 add on fee) – Any unmarried person reaching his or her twenty-second (22nd) birthday and presently eligible for membership under an existing 'Family' membership shall be eligible to continue membership under the family plan by payment of a fee to be set by the RH Board annually. Adult dependents may use the facilities with or without member being present and have full access and privileges of pool membership (may bring guests by purchase of guest pass, rent pavilion, etc.). This fee shall be waived if the individual is a member of the Armed Forces on active duty, upon presentation of proper credentials. *No voting rights or equity.*

Baby-sitters, nannies or au pairs (\$50 add on fee) may be listed for an additional fee to be set by the RH Board annually. Non-member babysitters/nannies/au pairs will be allowed entrance only while performing babysitter duties at the pool. Please see the manager if you need to register more than one sitter. A babysitter (non-family) must be at least 15 years of age.

Membership Mortgage Adjustment – a \$50 membership approved fee is added to the annual dues for all returning members
